SAMPLE SCHEDULE

Monday- Welcome and Safety Orientation:) Lay out your brushes in order with bareback pad and bridle. Learn how to safely halter and groom then tack up your mount. Western reins steering, back up, whoa! Muck stalls and put in new bedding! Lasso plastic bull and tie knots!

Tuesday- Western trail learning poisonous plants (castor bean, morning glory, poison oak) along with edible plants (blackberries, boysenberries, fennel, lemon berries).

Learn tack parts (of English and Western saddles & bridles), cleaning tack, and lasso some more!

Wednesday- English reins learning how to steer, rein back, and halt, plus proper English position! Learn about feed and hay, also Tiffany shows how to trim a horses' hooves while learning about the farrier's tools!

Thursday- English on trail finding California sage, fig plants and wild cucumbers. Anatomy of a horse along with identifying horse colors and breeds for all of our horses plus horsemen's terms!
